<p>THIS PERMIT BECOMES NULL AND VOID IF WORK OR CONSTRUCTION AUTHORIZED IS NOT COMMENCED WITHIN 6 MONTHS OR IF CONSTRUCTION OR WORK IS SUSPENDED OR ABANDONED FOR A PERIOD OF 1 YEAR AT ANY TIME AFTER WORK IS COMMENCED. No alteration or change shall be made in wiring and permanent electrical installations of any building which will presently or potentially constitute and addition in load of 700 watts or 875 volt-amperes without securing a written permit therefor, and no installation in any building possessing no electrical installations or wiring shall be made without first securing written permission therefore. The City Electrician may require a written description or diagram of such wiring before such permit is issued.</p> <p>No work shall be done before the permit is issued, and upon the completion of the electrical work and before the work is hidden from view by permanent installations of other material, the person shall submit such work for inspection and approval of the City Electrician. If such electrical work is not approved, it shall be corrected or destroyed within a reasonable time as determined by the City Electrician. No approval shall be issued unless all apparatus, wires, etc., connected therewith are set in conformity with the rules and regulations applicable thereto; nor shall any current be turned on until such approval is issued. The Electrical Contractor or his designated representative, and the Electrical Inspector shall be present at the location of the work for the preliminary and final inspections.</p> <p>Any person violating any provision of the electrical code of the City of Crawfordsville or failing to comply with the rules and provisions which may be established by virtue of powers invested by this code, or failing to comply with an order of the City Electrician made by virtue of the powers conferred on him by this code, may be removed from the electric service of the City's electric plant and / or be fined. Upon a second conviction, the City Electrician may, in addition to any fine or penalty imposed, revoke the electrical license held by such convicted person, and such person shall not have a license re-issued to him within one year from the date of revocation.</p> <p>I HEREBY CERTIFY THAT I HAVE READ AND EXAMINED THIS APPLICATION AND KNOW THE SAME TO BE TRUE AND CORRECT. ALL PROVISIONS OF LAWS AND ORDINANCES GOVERNING THIS TYPE OF WORK WILL BE COMPLIED WITH WHETHER SPECIFIED HERIN OR NOT. THE GRANTING OF A PERMIT DOES NOT PRESUME TO GIVE AUTHORITY TO VIOLATE OR CANCEL THE PROVISIONS OF ANY OTHER STATE OR LOCAL LAW REGULATING CONSTRUCTION OR THE PERFORMANCE OF CONSTRUCTION.</p>	Light
